

**Participant’s statement on Get Rainbowed**

I, the undersigned participant of the event. Get Rainbowed (hereinafter referred to as the „Action“) whose organizer is Events 4 you, ID: 03675131 with registered office at Prague 4, Mikuleckeho 1311/8 postal code 147 00 registered in the Federal register maintained by Municipal I accept and acknowledge that the Action is a test of physical and mental attributes which entails specific risks (in particular serious damage to health or property) by the court in Prague, Section L, file 61775 (hereinafter referred to as „the organizer“). By signing this statement all risks associated with my participation in the Action are freely, voluntarily and knowingly acknowledged, accepted by myself. I confirm that I am well, in good condition and I was not advised by the attending physician to participate in the Action.

In connection with my participation in the Action I acknowledge, accept and agree with the following:

Which the participants admits to the Czech legal order to such persons or entities: the organizer, his sponsors and co-sponsors, the directors of the factory and volunteers even though these claims, losses or liabilities are due to negligence through the act or omission of the above,
