#### 1. Definition of terms

Ticket owner

The Ticket owner is the person who has purchased the ticket through the service at the website domain www.getrainbowed.cz

Service

It is a seperate selling electronic way of ordering, selling and distributing electronic tickets.

Event

The event is a public social event with sporting character which is through the Service sell tickets and organized by the Organizer.

Organizer

Organizer is the entity, organization or facility organizing or operating events (such as sports events) which is provides the sale and distribution of tickets.

Ticket

The ticket is a confirmation enabling its owner to make a one-time payment for the Action for which it was held purchased. The ticket is valid only for the action it was purchased for. It can not be used for entry to another event.. The current prices of the tickets are published on the website www.getrainbowed.cz

Sort of tickets

Electronic form tickets are delivered to the owner at the e-mail address entere dat the time of closure orders.

# 2. Introductory provisions

The general terms of business specify the use of the service and define the contractual relationship between Events 4 you and the ticket owner.

- 2.1 The organizer accepts funds from the bidders corresponding to the purchase price of the tickets. By paying the price for the tickets via <a href="www.getrainbowed.cz">www.getrainbowed.cz</a> website enter the ticket owner to legal relationship directly with the specific organizer of the selected event.
- 2.2 Information about the change or cancellation of the event can be found on <a href="www.getrainbowed.cz">www.getrainbowed.cz</a>. Responsibility for the publication of a change or cancellation of an event has the organizer.

#### 3. Ordering and tickets payment

- 3.1 Tickets can be purchased via the service located on a domain site <a href="www.getrainbowed.cz">www.getrainbowed.cz</a> or in the day of the event at the latest 2 hours before starting the event.
- 3.2 Applicants may use the service as follows:

- 3.3 Payment for tickets is possible through payment systems
- bank transfer
- by credit card
- 3.4 The maximum number of tickets that can be purchased per customer is not limited.
- 3.5 The minimum number of tickets that can be bought at a discount for the team is 4.

#### 4. Rights and obligations of ticket owner

- 4.1 By purchasing tickets for each Action the ticket owner has entered into a contractual relationship with Events 4 you.
- 4.2 The ticket owner is entitled to use the ticket to enter the Action for which it was purchased.
- 4.3 The ticket owner is required to present a valid identify card at the request of the Organizer.
- 4.4 The ticket owner is required to check the ticket and the details on it immendiately after delivery (it is understood delivery to owner's mailbox)

## 5. Complaints regulations

- a. After purchasing the ticket the ticket cannot be withdrawn from the contract with the organizer and requested return of the starting fee. The organizer will not accept the refund of the already paid start of the event will take place. It is also not possible to request a refund if the ticket owner does not use it.
- b. Transfer of registration to another person is possible within the week before the Action and for an administration fee of 100,-CZK which will be credited to the organizer's account.

### 6. Protection of personal data

- 6.1. Events 4 you, zs in accordance with the provisions of Act No. 101/2000 Coll., the Personal data protection act and the amendment of some laws (hereafter referred to as the Personal data protection act) obtains and processes personal data ticket owners mainly in the range of name, surname, address, telephone/email contact, date of birth for purposes of administering the legal relationships arising from the conclusion of the contract between the ticket owner on the organizer in connection with the purchase of tickets for a specific event as well as for the purpose of recording the aktivity of the individual Event organizers. Provision of personal data is voluntary.
- 6.2. By purchasing the ticket, the ticket owner grants agreement to Events 4 you to process its personal data for the above purpose i nmeaning of Section 5 of the Personal data protection act. Ticket owner's rights remain valid under Section 21 of Personal data protection act.
- 6.3. Events 4 you undertakes that the personal data obtained in accordance with the provisions of § 13 seq. of the Personal data protection act will protect against accidental and unlawful damages and destruction, accidental loss, alternation, unauthorized access and disclosure as well as any other illegal forms of processing .
- 6.4. Events 4 you also undertakes to comply with the provisions of the Personal protection act keep confidential information about collected personal data.

#### 7. Final provisions

- 7.1. By purchasing the ticket its owner agrees with these General business terms and conditions.
