CONSENT TO THE PROCESSING OF PERSONAL DATA

By granting this consent to the processing of your personal data you agree that Events 4 you, as the organizer of the event Get Rainbowed will be authorized to proces your personal data under the terms and conditions below.

1. Identification and contact details of an administrator

- 1.1. The administrator of your personal data is the Events 4 you, ID: 03675131 with registered office at Prague 4, Mikuleckeho 1311/8 with postal code 147 00 registered in the Federal Register kept by the Municipal Court in Prague (hereinafter referred to as "administrator").
- 1.2. In the case of any queries or if you wish to enforce your statutory laws or revoke your consent to the processing of personal data given to the administrator please contact the administrator:

and the truste eis entitled to request proof of your identity in order to prevent unauthorized persons from accessing your personal data. In order to increase the quality of service and keep records of the fulfillment of the legal obligations between you and the manager is monitored.

2. Legal basis for the processing of personal data

The legal basis for the processing of your personal data is your consent given to that controller within the meaning of Article 6 (1) (a) Regulation (EC) No 2016/679 of the European Parliament and of the Council on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46 EC (General Regulation on the protection of personal data) this to the extent of the personal data necessary to fulfill the rights and obligations arising from your registration to participate in the Get Rainbowed event.

3. Scope of processing of personal data

- 3.1 The administrator will process your personal data to the extent it was provided to you in connection with your future participation in the Get Rainbowed event. Which you will participate in as your registration within the scope of:
 - Photohraps, portraits and videos capturing your person at the event of Get Rainbowed (collectively reffered to as "photographs"),
 - Your starting number under you will participate in the Get Rainbowed event,
 - Your name and surname

(hereinafter together as "personal data").

- 3.2 The administrator will further proces the data on how you gave us permission to proces your personal information (usually by stating the time of your consent including your IP address from which your e-mail address was filled out) and when you removed it.
- 3.3 Any other personal data you provide to us in conncetion with your registration to participate in the Ger Rainbowed event will be handled by the administrator pursuant to the provisions of Article 6 par. 1 (b) of the Regulation that processing of such personal data (date of birth, address, contact email) is necessary to fulfill the contact and that is for your participation in the event. 4. Purpose of the processing of personal data

The purpose of processing your personal information is to publish your name and surname with your starting number for a maximum of 60 days after the end of each event Get Rainbowed on www.getrainbowed.cz together with a photo file where you can view and download the photos and the use (including publication, reproduction, distribution on the territory of the Czech Republic and the Slovak republic) of photos by the administrator fot the purpose of advertising (in the internet, in the

pressm on television, in the promotional materials) in the future events of Get Rainbowed fot the period in Arcticle 5 of this agreement.

5. <u>Time of storing personal data</u>

The administrator will process your personal data fot the duration of the contractual relationship and subsequently for a further 10 years if that consent is not revoked by you for processing your personal data.

6. Where will your data be processed?

We will processing your personal data in our internal computer systems.

7. Other recipients of personal data

- 5.1. We will not pass your personal data to third parties anymore.
- 5.2. Your personal data may be accessed to a certain extent by persons who are performing support activities for us such as operators of our IT systems, operators of our backup servers and data backups.
- 5.2. The administrator does not intend to pass your personal data to a third country (to a non EU country) or an international organization.

8. Revocation of personal data

You may revoke this free of chargé your consent to the processing of your personal data by sending an e-mail to: info@events-4-you.cz or other means referred to in Article 1.2. at any time. Revocation of consent is without prejudice to the lawfulness of processing baed on consent given prior to his / her removal. Revocation of consent also has no effect on the processing of personal data processed by the controller on the basis of a legal basis other than consent (in particular, if the processing is necessary to fulfill the contract, legal obligations or for other reasons stated in the applicable legislation).

9. Information about your rights

- 9.1. Please note that any infrmation you provide to us and making them is voluntary. You have no obligation to provide it. In the case of your personal data you provide there are no sanctions. However If you do not provide your personal information to an administrator you will not be given the opportunity to view and download the photos and enjoy them for your personal needs. However i tis entirely up to you to decide whether or not you enter into a contractual relationship with the trustee.
- 9.2. In relations to your personal data, you have the following rights:
 - a) the right to withdraw their consent at any time, however this is without prejudice to the lawfulness of processing your personal information prior to such withdrawal of consent,
 - b) the right to correct ot add personal information,
 - c) the right to require processing restrictions,
 - d) the right to object or complaint against processing in certain cases,
 - e) the right to request the transfer of data,
 - f) the right of access to personal data,
 - g) the right to be informed about a personal data breach in certain cases,
 - h) the right to delete personal data (the right to be "forgotten") in certain cases
 - i) and other rights set out in the Personal Data Protection Act and General Personal Data Protection Regulation No. 2016/679.

10. Securing personal information

All personal information provided by administrators is secured by standard procedures and technologies. However, it is not objectively possible to fully guarantee the security of your personal data. Therefore i tis not even possible to ensure 100% that personal data provided can not be accessed by a third party, can not be copied, disclosed, altered or destroyed by breaking the security measures of the controller. In this context, however, the trustee warrants that it regurarly checks that the systém is free from vulnerabilities and is not exposed and uses security measures that can reasonably be required by the controller to prevent unauthorized access to the personal data
